On July 2, 2004, the Arizona Department of Water Resources ("ADWR") filed a Draft Supplemental Contested Case Hydrographic Survey Report ("HSR").

The Special Master wishes to remind parties and claimants in the Little Colorado River Adjudication of their opportunity to submit comments to ADWR regarding content and formatting issues on or before **Friday, October 1, 2004**. The comments should assist ADWR to produce a practical and useful HSR for the limited scope of a contested case. Comments shall not address the merits or attributes of any specific water right as these matters are reserved for later hearing. Persons submitting comments shall provide a copy to all persons appearing on the mailing list for this contested case and on the Little Colorado River Adjudication Court-Approved Mailing List.

ADWR has been directed to consider the comments and prepare a final supplemental contested case HSR which shall be filed on or before January 31, 2005.
