STIPULATION TO EXTEND TIME  
LINES AND MODIFYING THE  
SCHEDULING ORDER FOR THE  
SECOND PHASE OF THIS CASE

CONTESTED CASE NAME: *In re Fort Huachuca.*

HSR INVOLVED: San Pedro River Watershed Hydrographic Survey Report.

DESCRIPTIVE SUMMARY: The Special Master issues an amended order nunc pro tunc clarifying the time lines for completing discovery and exchanging expert reports.

DATE OF FILING: April 17, 2013.

After considering the Joint Request of Freeport-McMoRan Corporation and the United States for Clarification Regarding Extension of Deadlines, the Special Master issues this amended order nunc pro tunc. The time line dates were transposed in the February 27, 2013, order and are corrected.

As procedures can change, the Special Master will provide the instructions for telephonic access at a later date prior to June 11, 2013. The information will be provided

by electronic mail.

On February 19, 2013, the United States and Freeport-McMoRan Corporation filed a stipulated request to extend the time lines for completing discovery and serving expert reports. These parties are engaged in extensive discovery and need the additional time to complete discovery and expert reports. The request will be granted.

The telephonic conference set for June 11, 2013, at 9:00 a.m. (MST) will not be reset to a later date. The Special Master does not want this phase to bog down in discovery issues and wants to assure that this matter proceeds efficiently. He is inclined not to grant any further requests or stipulations for additional time concerning discovery and expert reports.

IT IS ORDERED:

1. Modifying Section II, Paragraph 4(C) (Discovery) of the Scheduling Order dated December 19, 2011, to provide that all discovery including depositions shall be completed by **Friday, October 4, 2013**.

2. Modifying Section II, Paragraph 5 (Expert Reports) of the Scheduling Order dated December 19, 2011, to provide that on or before **Friday, August 2, 2013**, all parties will exchange expert reports that a party considers relevant to the designated issues. And,

3. No other changes to the Scheduling Order are made.
