ORDER

CONTESTED CASE NAME: *In re Hopi Tribe Priority.*

HSR INVOLVED: None.

DESCRIPTIVE SUMMARY: The Special Master initiates proceedings to resolve ownership and priority issues remanded by the Court in its order determining the priority of water rights of the Hopi Tribe.

By order dated January 25, 2016, the Court remanded this matter to the Special Master to determine the dates after the issuance of the Executive Order of December 16, 1882, on which the United States acquired title to that real property within the boundaries of the Hopi Partitioned Lands, which includes Land Management District 6. In the proceedings before the Special Master, the parties have briefed this issue which concerns

aboriginal water rights or rights acquired under aboriginal title.

To expedite the resolution of the priority date for federal reserved water rights and to avoid the need to duplicate pleadings previously submitted, the dates the federal government acquired ownership from Santa Fe Pacific Railroad Company for parcels of land within the Hopi Partitioned Land and recording information where available is set forth below. The legal descriptions of the land from deeds without recording information are set forth or are attached in lieu of the deed information.

On March 29, 2016, a status conference shall be held to ascertain the issues in

dispute regarding the dates on which ownership was acquired by the federal government of land within the Hopi Partitioned Land and schedule the necessary evidentiary proceedings to expeditiously resolve such issues. In addition, the parties should be prepared to discuss at the status conference appropriate proceedings to address the issue of whether the Hopi Tribe may assert a priority that is senior to the Navajo Nation for water resources shared by both tribes.

**IT IS ORDERED:**

1. Any party objecting to the date of acquisition, the transferring document, an omission of land, or an addition of land described above shall file an objection on or before **March 18, 2016**, which shall specifically identify the basis of the objection and briefly describe the evidence available to the objecting party supporting the objection.



THIS INDEED, made this twenty-fifth day of August, one thousand, nine hundred and thirty-four, by and between the SANTA FE PACIFIC RAILROAD COMPANY, a corporation, duly incorporated by Act of Congress approved March 3, 1897, party of the first part, and hereinafter designated the first party, and the UNITED STATES OF AMERICA, THE TRUST FOR THE NAVAJO TRIBE, party of the second part and hereinafter designated the second party:

WITNESSETH, That the first party for and in consideration of the sum of Two hundred forty thousand, nine hundred fifty-nine and 45/100 Dollars, (\$240,959.45), to it in hand paid by the second party, the receipt whereof is hereby acknowledged, conveys and quitclaims all of its right, title and interest in and to the following lands, situate in the Navajo Indian Reservation, which are unsurveyed and described according to protractors made by the Commissioner of the General Land Office, and from existing plan of survey along the Colorado River; and it is the purpose of this deed to convey all the right, title and interest of the Santa Fe Pacific Railroad Company in and to said lands, whether described as herein, or according to an actual survey made by the United States. Said lands are situate in Coconino County, State of Arizona, and are described as follows:
