The following attorneys appear telephonically:

Michael C. Kasper, David J. Scheier and Richard E. Rogers appear on their own behalf. Mark A. McGinnis, Lucas Shaw and Greg Kornrump on behalf of SRP; Tony Gioia and Steve Wene appear on behalf of Camp Verde.

The court advises the parties regarding the proper filing procedures pursuant to the Arizona Rules of Civil Procedure and to provide a copy of any filed documents to the court.

Counsel for SRP advises the court regarding the status of the remaining order to show cause. Counsel further advises the court that there is a draft of a settlement agreement that is not yet signed by the parties.

Mr. Rogers and Mr. Scheier advise the court they are not interested in settling the matter with SRP.

Mr. Kasper advises the court of his position with regard to the issue.

The court advises counsel and the parties that the best course of action to resolve this matter would be to set a firm date by which counsel will either file the executed settlement agreement with Mr. and Mrs. Kasper and Mr. and Mrs. Henry and file a Motion for Summary Judgment as to Mr. and Mrs. Scheier and Mr. and Mrs. Rogers.

Counsel for SRP agrees with the court's suggestion.

LATER:

The parties shall file by May 5, 2017, a Notice of Settlement if a settlement has been reached and SRP shall file a motion to dismiss its Application to Show Cause if the settlement is signed by all parties. If a settlement is not reached with all parties, SRP shall file a Notice of Settlement with respect to parties who have reached a settlement and shall file by May 5, 2017, a motion for summary judgment regarding the remaining parties. Responses shall be filed by June 9, 2017, and a reply shall be filed by June 29, 2017. Oral argument on the motion for summary judgment shall be held on July 12, 2017 at 1:30 p.m. at:
