The Maricopa County Public Defender's Office experienced a 36% increase in monthly net felony assignments between December, 1995, and August, 1996. It has not been authorized to hire any additional staff attorneys to handle this caseload increase. The result has been a dramatic increase in the average active and total caseloads of public defenders. Caseloads, particularly in Trial Group C, now exceed the level at which the Public Defender's Office was allowed to withdraw from cases, for ethical reasons, in 1994-95.

The Public Defender's Office has requested that it be relieved from representation on active cases formerly assigned to Slade Lawson and Mark Potter, two Group C attorneys who recently resigned, plus an additional number of recently-assigned Group C cases, to relieve the pressure of excessive caseloads on the Group C attorneys.

THE COURT FINDS that attorney caseloads in Trial Group C of the Maricopa County Public Defender's Office are excessive, preventing deputy public defenders from representing their clients in an effective and ethical manner.

IT IS THEREFORE ORDERED that the Maricopa County Public Defender's Office is relieved from representation of the defendant in each of the cases specified on the attached lists, identified as Exhibits A, B, and C, and that the Maricopa County Office of Court-Appointed Counsel is hereby appointed to represent those defendants.
