# New Judge Q-and-A: Joan Sinclair

## Governor Appoints Former Commissioner

The Governor appointed former Commissioner Joan Sinclair to the Maricopa County Superior Court.

“With more than two decades of courtroom experience in Arizona, Joan is well-rounded and well-suited for this important judicial role,” said Governor Jan Brewer.

Judge Sinclair was a Maricopa County Superior Court Commissioner since 2006. She originally presided over initial appearances in criminal matters and has been assigned to juvenile court since 2007.

Judge Sinclair has been licensed to practice law in Arizona since 1995. She also is a member of the New York and Georgia state bars. Prior to serving as a Court Commissioner for Maricopa County, she worked for several years in Atlanta, Ga., where her roles included: Social Security Disability Litigation Unit; Federal Highway Administration; and Dekalb County Juvenile Court Solicitor’s Office.

Since earning her license to practice in Arizona, Judge Sinclair served as a Maricopa County Attorney and worked for the Arizona Death Penalty Judicial Assistance Program. She also clerked for Chief Justice Bud Jones in the Arizona Supreme Court and practiced at firms Meagher & Geer and Dodge Anderson.

The Governor’s appointment of Judge Sinclair fills the opening created by the recent appointment of Judge Samuel Thumma to the Arizona Court of Appeals.

**Q. What has surprised you the most about making the transition from commissioner to judge? Please explain.**

I have not had any real surprises on the transition from commissioner to judge. It still sounds a little odd when people refer to me as judge.

**Q. Who has been the biggest inspiration in your legal career?**

My biggest inspiration in my legal career was former Arizona Chief Justice Charles Jones. I clerked for him from August 2001 to August 2002. It was a wonderful experience seeing firsthand how he approached issues at the appellate level. I learned a lot that year both from the work and from him. I have also been inspired by former U.S. Supreme Court Justice Sandra Day O’Connor and former Arizona Chief Justice Ruth McGregor. These ladies have been role models for me.

**Q. What’s your favorite quote? (This can be something one of your children said to you, what you said to them, a line from poetry or something you wish you hadn’t said).**

My parents were happily married almost 41 years before my mother passed away. She used to say in jest when talking about her relationship with my father that “what’s mine is mine and what’s his is mine.” Thinking about that always makes me laugh.

**Q. If you had a day to spend with anyone (living or dead, real or fictional), who would it be and what would you do?**

If I had a day to spend with anyone, living or dead, I would spend the day with my mother and my daughters, just getting caught up on what’s been going on since she passed.

**Q. Do you own an IPOD? If so, what songs are currently in your playlist?**

I don’t own an IPOD-my children do, but I don’t.

# Color Guard Volunteers Wanted

The Maricopa County Color Guard is a group comprised of Maricopa County and Superior Court employees, who are either current or former military service members, that volunteer to post and retire the colors at county-sponsored events and functions. Besides the requirement of current or former military, the other requirements are that you possess a service dress uniform from your branch of service that is in good repair that fits you well, and you must be willing to maintain grooming standards that are in keeping with your branch of service requirements for wear of the uniform. Finally, you must be able to execute basic military marching commands.

The Maricopa County Color Guard receives requests throughout the year from the Board of Supervisors and the County Manager's Office to post and retire the colors at county-sponsored functions such as dedication ceremonies, diversity celebrations, and Memorial Day and Veterans Day events. As a volunteer, you should be willing to devote at least one hour of your time to the events you agree to attend.
