ADMINISTRATIVE ORDER

WHEREAS, A.R.S. § 12-213 authorizes the Presiding Judge of the Superior Court to appoint court commissioners to serve at the pleasure of the Presiding Judge; and

WHEREAS, the following attorneys are designated as Judges Pro Tempore of this Court pursuant to Administrative Order No. 2020-87.

**IT IS ORDERED** that the following attorneys are hereby appointed as on-call and part-time commissioners of the Superior Court in Maricopa County for the period of July 1, 2021 through June 30, 2022:

**IT IS FURTHER ORDERED** that these on-call and part-time commissioners shall have all such powers and duties pursuant to law which shall include, but not limited to, those powers and duties prescribed by A.R.S. § 12-213, as amended, and Rule 96, Rules of the Arizona Supreme Court, as amended.

**IT IS FURTHER ORDERED** that these on-call and part-time commissioners shall receive compensation for services rendered, if funds are available, at the rate of \$44.84 per hour. These appointments are based upon services of less than a full time basis and the annual compensation shall not exceed \$93,267.20 total. The on-call and part-time commissioners may agree in advance to donate any or all services to this Court.

**IT IS FURTHER ORDERED** that these appointments are conditioned upon the agreement to serve only for the compensation stated above while employed as an on-call and part-time commissioner by the Court, and to receive no additional compensation or benefit, fiscal or otherwise, when acting in the capacity of a judge pro tempore.
