ADMINISTRATIVE ORDER
No. 2024-016

WHEREAS Maricopa County Administrative Order No. 2023-179 provides that the Family Department in the Superior Court in Maricopa County shall use Case Center for the submission and management of digital evidence in trials and other evidentiary hearings before judges for all hearings in which hearing is set after January 1, 2024; and

WHEREAS it is in the best interests of the Family Department and its constituents to obtain feedback from a variety of members of the legal community, litigants, and third-party providers who assist self-represented litigants regarding the use of Case Center in Family Department matters;

IT IS ORDERED establishing a Family Department Case Center Community Workgroup. The purpose of the Workgroup is to advise the Family Department Presiding Judge and Family Court Administrator regarding the use of Case Center for the submission, management, and presentation of digital evidence by lawyers and litigants in Family Court matters. The Workgroup will meet once per quarter.

IT IS FURTHER ORDERED appointing the persons listed in **Appendix A** as Workgroup members beginning the date of this Order for a period of 12 months. The term of appointment may be extended at the discretion of the Family Department Presiding Judge. The Family Department Presiding Judge may appoint additional members as necessary.
