On March 27, 2025, the request of the Maricopa County Public Defender (MCPD) for transfer of representation in the cases detailed on the attached exhibit came before the court.

IT IS THEREFORE ORDERED that the Maricopa County Public Defender is relieved from representation of the defendant in each of the cases specified in the attached exhibit, and the Maricopa County Office of Public Defense Services is hereby appointed to assign counsel to represent those defendants.

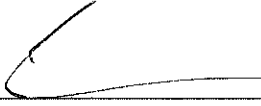
