WHEREAS, Administrative Order 2023-140 defines for Juvenile Court Cases, and

WHEREAS, the Juvenile Court seeks to ensure balanced workloads between the Southeast and Durango facilities, thereby providing improved case flow and reduced case delay for parties,

IT IS ORDERED:

1. The attached zip code listings separately identify the boundaries for each of the Juvenile Court districts in Maricopa County.
2. Juvenile Court cases appropriately filed in Maricopa County with the Clerk of Court shall be assigned based on the following:
 - a. the petitioner's address zip code set forth on the initial filing of petitions regarding adoption matters (JA);
 - b. by the facility of the specialty calendar assigned to manage adoption certification (AC), order of protection or injunction against harassment (JP), emancipation (JE), termination of parental rights (JS), appointment of a guardian for a minor (JG), parent/guardian consent related to ICWA cases (JI), temporary custody matters (Temp Cust JA), and dependency cases involving a child/parent under the Indian Child Welfare Act (ICWA JD);
 - c. the custodial parent or legal guardian's address zip code set forth on the initial filing of petitions or citations regarding delinquency matters (JV);
 - d. the custodial parent or legal guardian's address zip code set forth on the initial filing of petitions regarding dependency matters (JD) or, if the zip code is unknown, the zip code of the office of the Department of Child Safety investigator;
 - e. Juvenile Court Facility where it is presented for filing of petitions of notification (JN); and

- f. Juvenile Court Facility in which the initial filing was presented if there is no primary residence address zip code listed on the petition and it is not a case type handled by a specialized calendar.
3. Juvenile Court cases appropriately filed in Maricopa County with the Clerk of Court may be assigned to the same Juvenile Court Facility of an open related case under the *One Family, One Judge* practices.

This administrative order applies to all cases filed and initiated on and after the date of this order.

IT IS FURTHER ORDERED terminating Administrative Order No. 2023-140 effective this date.
