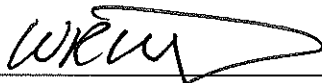

ADMINISTRATIVE ORDER

On July 2, 2026 the request of the Maricopa County Public Defender (MCPD) for transfer of representation in the cases detailed on the attached exhibit came before the court.

THE COURT FINDS that the request should be granted, and that representation should be transferred from the Public Defender to the Legal Advocate's Office, the Legal Defender's Office, and the Office of Public Defense Services, who does not object to this order.
