ADMINISTRATIVE ORDER
NO. 2010-117

Whereas, the Superior Court has for many years entered and approved various Administrative Orders, policies and procedures to regulate and manage the operation of the Justice Courts in Maricopa County; and

Whereas, a portion of those Administrative Orders, policies and procedures are now outdated, inconsistent or rendered superfluous by Supreme Court Administrative Orders 2006-56 and 2008-59, by the adoption of other superseding orders, policies and procedures, or by the passage of time, or by other circumstances or events; and

Whereas, the existence of numerous Administrative Orders, policies and procedures that are outdated, inconsistent or superfluous can create unnecessary confusion and inefficiency of operation; and

Whereas, the Superior Court has conducted an internal review of Justice Courts Administrative Orders, policies and procedures to determine which Administrative Orders, policies and procedures are outdated, inconsistent or superfluous,
