} ADMINISTRATIVE ORDER
No. 2011 – 064

WHEREAS, Arizona Supreme Court Administrative Order 2011-75 directed the Presiding Judge of the Superior Court in Maricopa County administrative oversight of the day-to-day operations of the Wickenburg Municipal Court; and

WHEREAS, the Supreme Court ordered the Presiding Judge of the Superior Court in Maricopa County to assign judges pro tempore and other judges as needed to conduct court business;

IT IS ORDERED appointing Superior Court Commissioner David Cunanan as a judge pro tempore for Wickenburg Municipal Court, to serve on Monday, June 27, 2011, for no compensation or benefit, fiscal or otherwise, other than that to which he is entitled as his position as a Court Commissioner. A subsequent administrative order shall be issued providing for judge pro tempore coverage for future court dates until a presiding magistrate is hired by the Town of Wickenburg.

IF IS FURTHER ORDERED appointing Danna Quinn with Court Administration for the Superior Court in Maricopa County to act as a liaison with the Wickenburg Municipal Court and conduct any assessments necessary, reporting jointly to the General Jurisdiction Court Administrator or his designee, and the Presiding Judge of the Superior Court in Maricopa County. Ms. Quinn shall have the authority to bring in additional staff as necessary from Superior Court Administration and shall have the authority to effectuate recommendations and improvements based on assessments conducted as a result of this order or any audit from the Administrative Office of the Courts. The Wickenburg Municipal Court and the Town Manager, and staff operating under the Town Manager's control, shall provide Ms. Quinn or her designee any and all data and information requested related to the operations, personnel, workload, finances, systems, and procedures of the court.

IT IS FURTHER ORDERED the Town of Wickenburg shall reimburse Ms. Quinn and any employees who work on-site as a result of this administrative order for reasonable mileage expenses from their normal places of employment, provide parking as necessary, arrange for adequate office space, provide keys and access codes to court facilities, and ensure effective voice (phone) and data (fax and computer) connections to allow them to perform their work. Salary and fringe benefit costs of any Court Administration staff from the Superior Court in Maricopa County, including Ms.

Quinn, shall remain the responsibility of the Superior Court in Maricopa County until further order.

IT IS FURTHER ORDERED that this Administrative Order expires automatically without further Order on a date ten (10) years from the date of issuance in accordance with Arizona Code of Judicial Administration, Section 3-402(C), unless sooner modified, amended or replaced.
