ADMINISTRATIVE ORDER  
No. 2015-102

The Superior Court has a standing committee, the Public Access to Court Services Committee (PACS), established pursuant to Superior Court Administrative Order 2012-033, and subsequently updated by Superior Court Administrative Orders 2015-061 and 2015-088, to evaluate, monitor, coordinate, simplify, and clarify the various court functions, programs, information systems, and methods that provide information and services to the public, and to develop, recommend, and implement improvements in the manner and methods the court delivers information and services to the public.

The purpose of PACS is being redirected towards users of the Court's Law Library and Law Library Resource Center (LLRC). Thus, PACS will now consist of two subcommittees: the Self-Service Resources Advisory Subcommittee and the Law Library Advisory Subcommittee. The Self-Service Resources Advisory Subcommittee, previously the Law Library Resource Center Committee, will provide guidance in the LLRC reengineering process, including implementation of the Navigator Program, transition to more electronic resources, expansion of electronic legal forms, court navigation materials, and enhanced self-service forms. The Law Library Advisory Subcommittee will provide guidance in the Law Library Resource Center reengineering process, including the selection of electronic and paper law library resources and the retention of resources.

Providing better resources and materials to persons visiting the Court's Law Library and Law Library Resource Center impacts every department of the court. Accordingly, every court department should be represented on PACS. Therefore,

**IT IS ORDERED** appointing the Honorable Janet Barton (Presiding Judge), the Honorable Randall H. Warner (Civil Department Presiding Judge), the Honorable Sam J. Myers (Criminal Department Presiding Judge), the Honorable Paul McMurdie (Family Court Presiding Judge), the Honorable Colleen McNally (Juvenile Court Presiding Judge), the Honorable Andrew Klein (Probate/Mental Health Department Presiding Judge), the Honorable Christopher T. Whitten (Tax Court Presiding Judge), the Honorable Pamela Gates, the Honorable Mark H. Brain, Deputy Court Administrator Richard Woods, and Law Library Director Shawn Friend to the Public Access to Court Services Committee, effective October 1, 2015 until further order of the Court. Judge Dean M. Fink is the chair of the Public Access to Court Services Committee, pursuant to Administrative Order 2012-036.

**IT IS FURTHER ORDERED** establishing the Self-Service Resources Advisory Subcommittee and appointing the Honorable Pamela Gates and the Honorable Dean M. Fink to chair the subcommittee, effective October 1, 2015 until successors are appointed.

Judges Gates and Fink shall have the authority to appoint subcommittee members, and the Court Administrator shall provide staff support to the subcommittee.

**IT IS FURTHER ORDERED** establishing the Law Library Advisory Subcommittee and appointing the Honorable Mark H. Brain to chair the subcommittee, effective October 1, 2015 until a successor is appointed. Judge Brain shall have the authority to appoint subcommittee members, and the Court Administrator shall provide staff support to the subcommittee.

**IT IS FURTHER ORDERED** terminating Superior Court Administrative Order 2014-133.
