In September 2008, the Arizona Supreme Court issued an order formally adopting the Arizona Rules of Probate Procedure and the Appendix of Forms, which Rules have an effective date of January 1, 2009. It is the intention of the Arizona Supreme Court that these Rules of Probate Procedure supplant and replace all Local Rules of Practice that have been previously adopted in any Arizona County that pertain to practices and procedures in the administration of probate and mental health cases arising pursuant to Title 14 and Title 36, Arizona Revised Statutes. Based on the foregoing,

IT IS ORDERED that effective January 1, 2009, Rule 5, Local Rules of Practice for Maricopa County pertaining to probate and mental health cases is hereby rescinded.
