The Court asks Mr. Brown whether his client intends to pursue claims for water rights.

Mr. Brown states three members of the Board are present on the phone: Scott Pralinsky, Leslie Sansone and Tom Duncan. He describes the facility as a place that teaches autistic adults how to work on the farm. Water is a critical aspect of the whole operation. He needs access to National Archives to determine what the appropriate priority date might be. They re-opened about ten days ago, but he can't get any responses back from them. Because of the high demand they won't give a time frame of when the documents will be available. He requests an opportunity to provide notice when the documents are received and the amount of time that will be needed after he gets the documents to put together draft abstracts.

Mrs. Ransom states she is in the same position as Mr. Brown. My clients are searching our own personal records as my clients are the heirs of Mr. Kolbe.

The Court states in other cases what has been done once Mr. Brown obtains the records needed, he will notify the Court.

Mrs. Ransom states that is acceptable to her.

Mr. Brown and Mrs. Ransom will provide notice to the Court once the documents have been obtained from National Archives.
