Court Reporter, Teri Veres, is present. A record of the proceeding is also made digitally.

Preliminary matters are discussed including legal descriptions for land included in the Hopi Reservation. Counsel for the United States confirms that two legal descriptions

in LCR exhibits 72 and 1457 are correct. The United States proposes and requests that the Court allow it to circulate a draft stipulation amongst opposing counsel with the legal descriptions attached as exhibits and further discuss the stipulation with the Court next Tuesday after testimony of the last witness.

Further discussion is held regarding the legal descriptions being a part of the record in this matter. The Court suggested that if the parties can stipulate to the legal descriptions, then a stipulation can be admitted into evidence. Ms. Willard discussed attaching exhibits to a stipulation and then moving to reopen the record to admit the stipulation. No party objects to the proposed approach. Mr. Heisermann suggested that the stipulation should be completed before the deadline for filing statements of fact.

Discussion is held regarding the status of City of Flagstaff's witness, Alan Kleinman. Counsel states that Mr. Kleinman was not deposed and proposes that the Court take judicial notice of Special Master Tuttle's February 22, 1982 report which contains Mr. Kleinman's past testimony and opinions in lieu of Mr. Kleinman testifying in this matter. The City of Flagstaff requests that the Court allow it several days to work with the parties to determine if the parties can come to an agreement about Mr. Kleinman.

Navajo Nation will need to see what portions of the report the City is asking to be admitted before it can consider a stipulation.

United States objects to any use of the Tuttle report from the 1980s as a substitute of the testimony of Dr. Kleinman.

Mr. Campbell joins in Navajo Nation's comments.

Richard John Tadder is sworn and testifies.

City of Flagstaff exhibits 009 and 037 are received in evidence.
