On March 22, 1993, an Assignment of Statement of Claimant was filed with the Arizona Department of Water to assign from Jack K. Hughes et al. to the Bureau of Land Management Statements of Claimant 39-10797, 39-11599, 39-12585, and 39-14487. The Arizona Department of Water Resources investigated the claims and filed a report stating its findings

1 with respect to irrigation on the claimed location. Pursuant to A.R.S. §45-256, claimant may  
2 present evidence in support of a claimant's claim. A status conference was held in this case on  
3 September 10, 2020 in this case to determine if claimants intended to pursue their claims for  
4 water rights and begin the proceedings where necessary. No appearance was made at the status  
5 conference on behalf of the Bureau of Land Management. Due to lack of action and  
6 participation in this case,  
7

8 **IT IS ORDERED** that an authorized representative of Bureau of Land Management  
9 shall appear telephonically on October 9, 2020 at **2:30 p.m.** to provide good reasons that  
10 Statements of Claimant 39-10797, 39-11599, 39-12585, and 39-14487 should not be dismissed  
11 and no further proceedings undertaken in this case with respect to potential water rights for  
12 irrigation use and wildlife watering.




