This case will determine rights to water uses investigated in Watershed File Report 113-14-AA-009 (“WFR”) and resolve objections to the WFR. The WFR identified three potential water rights for irrigation use. On April 1, 2021, the Arizona State Land Department filed a Status Report advising that it did not intend to pursue claims for any of the irrigation water uses

1 and further stating that The Nature Conservancy also did not intend to pursue water rights for
2 irrigation use. The remaining party, Rogers Heaven Sent Ranch LLC, is reportedly intending to
3 pursue potential irrigation water right designated by Arizona Department of Water Resources as
4 IR003.



10 prepared to identify the Statements of Claimant that may be dismissed.
 - 11 2. At the Status Conference, Rogers Heaven Sent Ranch LLC shall report on
12 the status of the discussions among the parties regarding a stipulated abstract
13 for 113-14-AA-009-IR003. If no agreement to a stipulated abstract has
14 been reached, Rogers Heaven Sent Ranch LLC shall be prepared to identify
15 the relevant statement of claimant and legal basis that supports its claim for
16 the water right. It shall also be prepared to advise about the status of the
17 map that will be used to define the place of use for the claimed water right.
