Robert J. and Nancy J. Farrier filed Statements of Claimant for rights to water for irrigation and domestic uses on land in section 6 T6S R16E. The Arizona Department of Water Resources investigated the claims and reported that it did not find the claimed use of water on

the property. Mr. and Mrs. Farrier did not file an objection to the report prepared by Arizona Department of Water Resources. Objections were filed by the Gila River Indian Community, San Carlos Apache Tribe, Tonto Apache Tribe, Yavapai-Apache Indian Community and Camp Verde Reservation.

At the Status Conference held on February 4, 2020, Mr. Farrier appeared and stated that he wanted to pursue the water right originally claimed as well as rights for stock watering. Mr. Farrier was directed to file an amended Statement of Claimant by March 9, 2020. A review of the public records does not show that an amended Statement of Claimant has been filed.

Accordingly,

IT IS ORDERED that a Scheduling Conference shall be held telephonically on May 14, 2020 at 1:30 p.m. to identify the issues that must be resolved with respect to the claims and objections as filed, implement a discovery plan, if discovery is warranted, and schedule a date for a hearing so that each party will have an opportunity to submit evidence in support of the party's position.
