On November 1, 2019, Carol Steele and Lazaro Cervantes (Claimants) submitted a Notice of Filing Surface Water Statement of Claim and Statement of Claimant representing that they had

1 filed Statements of Claim for irrigation, stockwatering, and domestic use on the land investigated
2 by Watershed File Report 115-04-ADC-001 (WFR). Draft abstracts have been prepared by counsel
3 for the uses included in the WFR and distributed to the objecting parties. On January 24, 2020, the
4 San Carlos Apache Tribe filed a Report stating that it has reviewed the draft abstracts but are waiting
5 for updated drafts from Claimants that will be prepared once information is received from Arizona
6 Department of Water Resources regarding Claimants' surface water claims.

9 **IT IS ORDERED** that Arizona Department of Water Resources shall file a Report by
10 **April 1, 2020** regarding the status of the Statements of Claim filed by Carol Steele and Lazaro
11 Cervantes on November 1, 2019, for use of water on sections 3 and 4 Township 7S Range 17E.
