2:11 p.m. This is the time set for a status conference in this consolidated case to address watershed file reports 115-05-036 and 115-05-DA-003.

A record of the proceedings is made by FTR for a portion of the hearing; no Court Reporter is present.

The Court thanks ADWR for putting together a comprehensive review of the draft abstracts for the Court. The Court also noted that ADWR was able to locate assignments of water rights documents.

Mr. Brown reports that the Cavenders are in Michigan through October and do not have access to their files until such time as they return. Mr. Brown requests that the Court allow additional time to file the appropriate Statements of Claimant (SOCs) and assignments. He requests until January 10, 2020 to do so. Mr. Brown requests that a telephonic Status Conference be set for January 15, 2020.

IT IS ORDERED that by **January 10, 2020** Mr. Brown shall provide a list of all Statements of Claimants that the Cavenders have filed or pursuant to which they claim water rights that have been the subject of investigation by ADWR and included in the San Pedro HSR so that the Court may initiate and consolidate those cases with this case.

Ms. Magoffin states it is her belief that most of the irrigated land included in the watershed file report is on the Cavenders' land. Ms. Magoffin has both the well and the deeds to claim number: 115-05-DA-003-SR003. She believes that her land (Magoffin land) is not irrigated. She adds that another claim in SE NE SW is her water right for stock ponds and stock watering. The irrigation claims are for the Cavenders. Ms. Magoffin states that the Cavenders have an abstract that is actually on her land (SR003 – proposed water right), which should be in the Magoffin trust. SR002 is the correct water right.

IT IS ORDERED that Ms. McGoffin shall compile a list of the SOCs pursuant to which she asserts a water right on or with respect to the land included in watershed file reports 115-05-036 and 115-05-DA-003. She shall file the list with the Clerk of the Court and all parties listed on Attachment F to the Order to Initiate Contested Cases filed August 7, 2019.

In January 2020 the court shall hold a status conference to sort out the claims and schedule any proceedings necessary.

Discussion is held regarding ownership of the Klondyke cemetery. Mr. Brown stated that he believed that the Cavenders own the property. The Court requests that if the parties have any documentation with respect to the ownership of the land to please file it with the Court.

## LATER:

IT IS FURTHER ORDERED that by **January 10, 2020**, the landowners identified in the proposed abstracts reviewed by ADWR shall file:

- 1. Assignments of Statements of Claimant pursuant to which the respective landowners make a claim for a water right if the original claimant or authorized representative can be located;
- 2. Responses to Comments filed by ADWR to the proposed abstracts for which the landowner seeks a water right.
- 3. Any amendments to Statements of Claimant that the landowners believe appropriate to better describe and support the attributes of the claimed water rights.
