

On August 16, 2019, Arizona State Land Department filed a Request for Extension of Deadlines that included an extension of the deadline for Anthony Lunt to file an assignment of a Statement of Claimant for which Mr. Lunt is the Claimant from Mr. Lunt to Mr. Lunt as trustee of the Galiuro Trust.

LAND

The land involved in this case is owned by the State of Arizona. It is located in section 12 T9S R20E and sections 6 and 7 T9S R21 E. A map of those sections is shown below. The State of Arizona currently leases this land to the trustee of the Galiuro Trust.



HISTORY OF CLAIM

Mike Islely filed four Statements of Claimant for water rights for use on Section 12 Township 9S Range 20E and Section 6 Township 9S Range 21E. In 1990 Michael Isley and Elnora Isley assigned the Statements of Claimant to Anthony Lunt. A copy of the assignment is attached as Attachment A. Mr. Lunt and the Arizona State Land Department have agreed that Mr. Lunt owns the right to water for stock watering from Rudulpho Spring described as potential water right 115-10-013-SW001 located in Section 6 Township 9S Range 21E. The water right is the subject of Statement of Claimant 39-4210 for which Mr. Lunt is the current Claimant.

At some time after 1990, the grazing lease between Mr. Lunt and the Arizona State Land Department was amended or reissued to the Galiuro Trust. According to the public records of the Arizona State Land Department, the Galiuro Trust leases Section 12 Township 9S Range 20E and Section 6 Township 9S Range 21E. Under the court orders that govern this adjudication, a person who transfers land or an interest in land for which a water right is claimed has the obligation to notify Arizona Department of Water Resources (ADWR) and complete the forms required by ADWR, which in this case is an assignment. *See* Pretrial Order No. 4 (January 24, 2000). Because the interest in the leased land has changed from Mr. Lunt to the Galiuo Trust, the court order requires an assignment of the Statement of Claimant from Mr. Lunt to the trustee of the Galiuro Trust.

IT IS ORDERED granting ASLD's motion to extend the deadline for Mr. Lunt to file the required assignment of Statement of Claimant 39-4210 and Application for Assignment of Statement of Claimant 36-82403 to the trustee of the Galiuro Trust. The deadline for filing is **September 20, 2019**.

IT IS FURTHER ORDERED that ASLD shall file by September 20, 2019 its reasons that Statement of Claimant 39-7105 should not be dismissed and Statement of Claim 36-005115 should not be withdrawn.
