IT IS ORDERED that counsel for the Navajo Nation provide a list of lay witnesses vs. expert witnesses with the revised witness calendar.

Discussion is held regarding the Status Conference scheduled for April 28, 2023. The Court inquires whether the parties are able to hold the conference today instead.

Counsel for the San Juan Southern Paiute Tribe, Ms. Shaffer, states that she must confer with co-counsel, Ms. Kolsrud, before the Status Conference.
