Counsel for LCRC, Mr. Pew, objects to this witness testifying regarding an undercount as to lack of foundation.

Counsel for SRP, City of Flagstaff and ASLD join in the objection.

The objection is sustained.

Witness, Shem Liechty, testifies further.
