LET THE RECORD REFLECT that Court Reporter, Nicole Bulldis, was previously sworn on the third day of trial.

Witness, Shem Liechty, having been previously sworn, testifies further.

Counsel for ASLD, Ms. Brennan, objects to this witness testifying whether Navajo Nation's exhibit 983, calls for relying on an undercount as this witness is not a demographer.

Counsel for the Navajo Nation, Mr. Leonard, replies that he is not asking the witness to opine on an undercount. Mr. Thomas emphasized Mr. Liechty's involvement in the study and he is asking him what the study says.

Counsel for SRP, Mr. McGinnis, further adds that the document is already in evidence and apart of the record.

Counsel for City of Flagstaff, Mr. Thomas, further adds that the witness is not a surface water quality expert.

The objection is sustained.

Discussion is held regarding Mr. Liechty's testimony with Mr. Thomas on Monday.

Witness, Shem Liechty, testifies further.

Counsel for City of Flagstaff, Mr. Thomas, objects to the witness testifying about whether the report was opining on future demands.

Counsel for LCRC, Mr. Pew, further objects as to leading.

The objections are sustained.

Witness, Shem Liechty, testifies further.

Counsel for LCRC, Mr. Pew, objects to this witness testifying to something not in his report as to foundation, speculation, and facts not in evidence. City of Flagstaff joins.

Counsel for the United States, Mr. McBride, states that the position the US holds is that the 1934 Indian Reorganization Act includes the San Juan Southern Paiute Tribe.

Mr. Hiller states that he believed the question was regarding exclusive rights, but will withdraw the objection if that is not the case.

Counsel is directed to rephrase the question.

Counsel for United States, Mr. McBride, objects as to relevance.

The objection is overruled.

San Juan Southern Paiute Tribe's exhibit 51 is received in evidence.
