10:00 a.m. This is the time set for Trial to Court regarding Phase 1 – DCMI and Stock/Wildlife Watering before Special Water Master Sherri Zendri.

Court Reporter, Cindy Mahoney, is present. A record of the proceedings is also made digitally.

**LET THE RECORD REFLECT** that Court Reporter, Cindy Mahoney, was previously sworn on the first day of trial.

Counsel for Navajo Nation, Mr. Leonard, addresses the Court regarding Ms. Starosta. He explains that their surface water expert was Kirk Westphal who was previously with Brown and Caldwell. His new employers would not permit him to testify in this matter, therefore, with consent from the other parties, the Navajo Nation will be using Ms. Starosta (who worked with Mr. Westphal on this project) as their expert witness.

Counsel for United States, Ms. Blades, addresses the Court regarding Chris Banet's testimony. Mr. Banet is travelling from New Mexico for what is anticipated to be less than an hour of testimony. The parties discuss the possibility of Mr. Banet appearing virtually or admitting his report in lieu of his testimony. The Court will allow the parties time to discuss this proposal and address it after today's lunch break.

Witness, Lauren Starosta, is sworn and testifies.

Navajo Nation's exhibits 401, 402, 403, 404, 405, 406 and 1056 are received in evidence.

11:13 a.m. The Court reconvenes with the above-named parties present.

Witness, Lauren Starosta, testifies further.

1:29 p.m. The Court reconvenes with the above-named parties present with the exception of Gus Guarino for the United States Department of Justice.

Counsel for City of Flagstaff, Mr. Thomas, moves for the admission of City of Flagstaff's exhibit 162. Counsel for Navajo Nation, Mr. Leonard, objects as to hearsay and relevance.

The objection is sustained and City of Flagstaff's exhibit 162 is not received in evidence.

Witness, Lauren Starosta, testifies further.

The witness is excused.

Counsel for the United States, Ms. Blades, addresses the Court regarding the agreement with the United States and the San Juan Southern Paiute Tribe. The two parties agree that Mr. Banet's opinions as expressed in US exhibit 8, would apply to the San Juan Southern Paiute Tribe as equally as it does to the Navajo Nation. All parties agree that Mr. Benet's report may be admitted without objection without his testimony. Good cause appearing,

IT IS ORDERED approving the parties' agreement.

United States' exhibit 8 is received in evidence.

**IT IS FURTHER ORDERED** that no trial shall be held on Thursday, June 22, 2023.
