LET THE RECORD REFLECT that Court Reporter, Nicole Bulldis, was previously sworn on the third day of trial.

Witness, Dr. Daoxian Shen, is sworn and testifies.

City of Flagstaff's exhibits 8 and 160 are received in evidence.

Counsel for Navajo Nation, Mr. Hiller, objects and moves to strike the conclusion regarding Blue Springs.

Counsel for City of Flagstaff, Mr. Minkin, responds that it is in the table of the report. Mr. Hiller withdraws his objection.

Counsel for SRP, Mr. McGinnis, objects as to disclosure.

Counsel for United States, Mr. Guarino, joins in the disclosure objection.

Mr. Minkin withdraws his question.

Witness, Dr. Daoxian Shen, testifies further.

Counsel for United States, Mr. Guarino, objects to the witness testifying regarding precipitation as outside the scope of his report. Mr. Guarino further moves to strike.

Counsel for Navajo Nation, Mr. Hiller, joins in the objection.

Counsel for City of Flagstaff, Mr. Minkin, withdraws his question and the response shall be stricken.

Witness, Dr. Daoxian Shen, testifies further.

Counsel for Navajo Nation, Mr. Hiller, objects to the witness opining on whether the sediment issues in the Little Colorado River could be managed under Rule 702 and 703 as Dr. Shen does not have the data to make such a conclusion.

Counsel for United States, Mr. Guarino, joins and notes that it is an opinion not expressed in his report. He further moves to strike the question and answer.

Counsel for City of Flagstaff, Mr. Minkin, reads from the report and notes that he asked for the witness' opinion on the potential.

Counsel for SRP, Mr. McGinnis, reads from the report.

The objection is overruled. The parties may address this during their respective cross examinations.

Witness, Dr. Daoxian Shen, testifies further.

Counsel for Navajo Nation, Mr. Hiller, objects to the witness giving conclusions regarding sediment loads outside the scope of this report. Counsel for City of Flagstaff, Mr. Minkin, responds that the witness analyzed data from the USGS.

Counsel for United States, Mr. Guarino, objects as to form.

The objections are overruled.

Witness, Dr. Daoxian Shen, testifies further.

Counsel for City of Flagstaff, Mr. Minkin, objects to the witness testifying regarding annual carry over storage as outside the scope of his expert opinion.

The objection is overruled, but Mr. McGinnis is asked to provide clarification to the witness.

Counsel for City of Flagstaff, Mr. Minkin, objects to the witness testifying regarding storage as outside of the report.

The objection is overruled.

Witness, Dr. Daoxian Shen, testifies further.

Counsel for City of Flagstaff, Mr. Minkin, objects to testimony regarding cost as he has not done a feasibility test.

The objection is sustained.

Witness, Dr. Daoxian Shen, testifies further.
