On June 24, 2024, the Court received *Joint Motion to Postpone Issuance of the Final Phase II HSR*, filed June 21, 2024, on behalf of the Navajo Nation, United States, Hopi Tribe, San Juan Southern Paiute Tribe, LCR Coalition<sup>1</sup>, Salt River Project Agricultural Improvement and Power District, Arizona State Land Department, City of Flagstaff, Atkinson Tarding company, and Arizona Public Service Company (the “Parties”).

Recognizing the benefit of the global settlement in process, wishing to encourage the Parties to focus efforts on resolution, and other good cause appearing,




1 stayed and the Arizona Department of Water Resources “(ADWR)” shall not issue the final

4 shall issue a notice regarding this Order to all recipients of the notice filed on March 28,  
5 2024, pursuant to Arizona Revised Statute §45-256(H).
