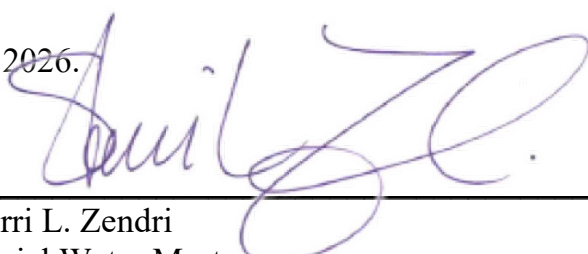
15 **DESCRIPTIVE SUMMARY:** This order grants claimant's request for an extension to
