DESCRIPTIVE SUMMARY: Order requesting Arizona Game \& Fish Department to file corrections to the map for proposed water right 033-56-DAB-001-SR001.

On November 20, 2023, the Arizona Game \& Fish Department ("AGFD") filed Motion for Approval of Stipulation for Proposed Water Right Abstract for the proposed water right $033-56-\mathrm{DAB}-001-\mathrm{SR} 001$. It is understood the proposed abstract and
accompanying map were reviewed by all parties to the case and there were no further objections to the abstract or map. However, the map provided may cause confusion in the event the water right needs to be enforced.

IT IS ORDERED that prior to final approval of the proposed water right 033-
$56-\mathrm{DAB}-001 \mathrm{SR} 001$ the following edits must be made:

1. Fully Shade or hatch the wildlife stockponds to denote they contain water.
2. The blue line through the center of the map does not appear to be relevant to the PWR so it should be removed. Otherwise, the relevance of the line should be explained in the legend.
3. The three "NW" in the lower left corner of the map do not appear relevant to the PWR therefore they should be removed, or their relevance explained.
4. The differentiation in the shading does not show up well. If the different landowners surrounding the PWR are not relevant, then do not include.
5. The Arizona Game and Fish Department boundary looks good on the map but does not show up in the printed legend. A heavier line or darker color would improve readability. Additionally, ensure that all text in the legend is within the printable margins.

The map, including the comments discussed above, is attached as Attachment A.
None of the edits ordered are substantive, however all parties shall have an opportunity to review the edits prior to filing with the Court. Accordingly,

IT IS FUTHER ORDERED that the updated map will be circulated to all parties prior to final filing with Court. The updated map shall be filed with Court no later than December 22, 2023.
