On December 14, 2017, the Salt River Project Agricultural Improvement and Power District and Salt River Valley Water Users' Association (Salt River Project) filed a motion to initiate a contested case and to designate an issue regarding the forfeiture of pre-1919 water rights as one of broad legal importance. Responses have been filed both joining and opposing Salt River Project's motion. Salt River Project has requested oral argument.
