This contested case will resolve objections to potential water rights for those owners of land that receive water diverted and distributed by the St. David Irrigation District. Thus, the primary purpose of this case is to adjudicate claims for rights to irrigation water from the St. David Irrigation District Ditch.

1 For example, the watershed file report beginning 112-17-BAD describes land located on the
2 map immediately east of Benson.

3 A copy of a watershed file report can be obtained from ADWR. A request can be made
4 online by accessing ADWR's webpage, <http://www.azwater.gov>, clicking on the Public
5 Records icon on the right side of the page under the heading "Contact Us!", and completing the
6 public records request. A request can also be made by emailing, faxing or mailing a
7 completed Public Information Request Form to ADWR. A copy of the form is attached to this
8 Order as Attachment B. The contact information for ADWR is printed on the first page of the
9 form.

11 **Court Proceedings**

12
13 By Order dated January 23, 1995, this case was initiated to resolve objections to the
14 watershed file reports listed on Attachment A. The objectors to the results of the watershed
15 file reports are listed on Attachment C. No proceedings in this matter appear in the court
16 records since 1995. Thus, a scheduling conference must be held to implement a process to
17 determine the proper parties who have claims for water rights to water diverted and distributed
18 by the St. David Irrigation District. This scheduling conference is not a hearing to determine
19 water rights. It is being held to determine procedures to move forward with this case and to
20 identify all of the parties desiring to assert water rights to water supplied from the St. David
21 Irrigation District Ditch.

24 Given that more than 20 years has passed since this case began, many parcels of land
25 involved in this case have changed ownership. The Arizona Department of Water Resources
26 has examined country assessor records to determine the current owners of the land which were
27

1 the subject of each of the watershed file reports included in this case. The names of the current
2 owners of the land associated with each watershed file report are shown on Attachment A.

3 The scheduling conference will also focus on the existing uses of water for irrigation
4 purposes. There may be landowners included in this case who have no interest in asserting a
5 right to water distributed from the St. David Irrigation District Ditch. In 1995, the Arizona
6 Department of Water Resources prepared a list of watershed file reports for land it described as
7 no longer receiving water diverted and distributed by the St. David Irrigation District. A list of
8 those watershed file reports is attached as Attachment D. As part of the proceedings in this
9 case, a determination will be made whether these watershed file reports should be excluded
10 from this case. Accordingly, at the status conference, St. David Irrigation District will be
11 requested to provide a list of the landowners who divert water from the St. David Irrigation
12 District Ditch to begin this process. The scheduling conference will also be a forum in which
13 to set a reasonable schedule to allow interested landowners to file amended claims for water
14 rights or obtain assignments of existing claims.

17 18 **Court Approved Mailing List**

19 An initial court-approved mailing list has been prepared which includes the persons and
20 entities that have been identified as current landowners, the St. David Irrigation District,
21 ADWR and those persons and entities who filed objections to the watershed file reports. A
22 copy of the initial court-approved mailing list is provided as Attachment E. The mailing list
23 may be modified only by filing a motion with the Special Master to amend the court-approved
24 mailing list. Litigants are responsible for using the current mailing list, which can be found on
25 the website for the General Adjudication. A copy of any pleading filed with the Clerk of the
26 Maricopa County Superior Court in this case shall be mailed or delivered to each person listed
27

1 on the court-approved mailing list. Claimants wishing to be added or removed from the
2 mailing list shall file a motion with the Special Master.

3 The Special Master's office will email courtesy copies of orders and minute entries
4 entered in this case to litigants who request to be added to the email list. Requests for
5 inclusions on the email list should be sent to Barbara Brown at
6 brownb099@superiorcourt.maricopa.gov.

A.R.S. § 39-121.03. Request for copies, printouts or photographs; statement of purpose; commercial purpose as abuse of public record; determination by governor; civil penalty; definition

- A. When a person requests copies, printouts or photographs of public records for a commercial purpose, the person shall provide a statement setting forth the commercial purpose for which the copies, printouts or photographs will be used. Upon being furnished the statement the custodian of such records may furnish reproductions, the charge for which shall include the following:
1. A portion of the cost to the public body for obtaining the original or copies of the documents, printouts or photographs.
 2. A reasonable fee for the cost of time, materials, equipment and personnel in producing such reproduction.
 3. The value of the reproduction on the commercial market as best determined by the public body.
- B. If the custodian of a public record determines that the commercial purpose stated in the statement is a misuse of public records or is an abuse of the right to receive public records, the custodian may apply to the governor requesting that the governor by executive order prohibit the furnishing of copies, printouts or photographs for such commercial purpose. The governor, upon application from a custodian of public records, shall determine whether the commercial purpose is a misuse or an abuse of the public record. If the governor determines that the public record shall not be provided for such commercial purpose the governor shall issue an executive order prohibiting the providing of such public records for such commercial purpose. If no order is issued within thirty days of the date of application, the custodian of public records shall provide such copies, printouts or photographs upon being paid the fee determined pursuant to subsection A.
- C. A person who obtains a public record for a commercial purpose without indicating the commercial purpose or who obtains a public record for a noncommercial purpose and uses or knowingly allows the use of such public record for a commercial purpose or who obtains a public record for a commercial purpose and uses or knowingly allows the use of such public record for a different commercial purpose or who obtains a public record from anyone other than the custodian of such records and uses it for a commercial purpose shall in addition to other penalties be liable to the state or the political subdivision from which the public record was obtained for damages in the amount of three times the amount which would have been charged for the public record had the commercial purpose been stated plus costs and reasonable attorney fees or shall be liable to the state or the political subdivision for the amount of three times the actual damages if it can be shown that the public record would not have been provided had the commercial purpose of actual use been stated at the time of obtaining the records.
- D. For the purposes of this section, "commercial purpose" means the use of a public record for the purpose of sale or resale or for the purpose of producing a document containing all or part of the copy, printout or photograph for sale or the obtaining of names and addresses from public records for the purpose of solicitation or the sale of names and addresses to another for the purpose of solicitation or for any purpose in which the purchaser can reasonably anticipate the receipt of monetary gain from the direct or indirect use of the public record. Commercial purpose does not mean the use of a public record as evidence or as research for evidence in an action in any judicial or quasi-judicial body.
