21 This case, W1-00-000103,¹ was initiated on February 24, 2003, for the purpose
22 of delineating the subflow zone for the San Pedro River watershed, subsequently for
23 proceedings related to *de minimis* standards in the San Pedro River watershed, and is
24 currently amid ongoing proceedings regarding the cone of depression and subflow
25 depletion testing for the San Pedro River watershed. Based on a review of this case file,
26 it appears that the initial Court Approved Mailing List (“CAML”) for this case was

1 created from case W1-00-001234,² *In re The General Adjudication of all Rights*
2 *to Use Water in the Gila River System and Source*. As objections and motions to
3 various reports have been filed, the CAML related specifically to W1-00-000103 has
4 grown and changed, however many parties remain on the CAML only as an artifact
5 from the initiating order and have never substantively participated in proceedings
6 related to this case.

7 Additionally, there are some parties who participated in this case initially but
8 have not actively participated in the proceedings in many years.

9 Due to changes in Court technology, and to minimize the effort and cost
10 associated with the service of documents, only the following parties will remain on the
11 CAML:

- 12 1. Parties who have filed an objection.
- 13 2. Parties who have filed a joinder to an objection.
- 14 3. Parties who have filed a motion to intervene.
- 15 4. Additionally, parties who have not participated in these proceedings in a
16 substantive manner in 10 years or more are removed from the CAML.

18 those who will remain on the CAML for this case.

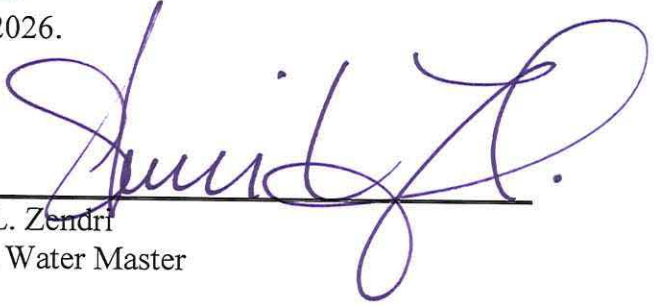
19 As this case has a long and complicated history, it is possible a party may be

26 will continue to receive those emails. If any person who is not include on the courtesy

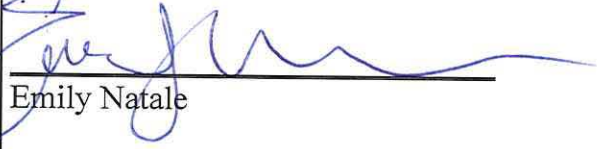
