17 This case, W1-11-000232, was initiated on September 26, 2006, for the
18 purpose of adjudicating both federal and state law based water rights associated with
19 the San Pedro Riparian National Conservation Area (“SPRNCA”). Based on the
20 Court’s understanding, the initial Court Approved Mailing List (“CAML”) for this
21 case was created from case W1-00-001234,¹ *In re The General Adjudication of all*
22 *Rights to Use Water in the Gila River System and Source*.

23 As objections and motions to various reports have been filed, the CAML
24 related specifically to W1-11-000232 has changed, however many parties remain
25 on the CAML only as an artifact from the initiating order and have never
26 substantively participated in proceedings related to this case. Additionally, some
27 parties have remained on the Court Approved Mailing list, after appearance of
28 counsel.

3 the CAML:

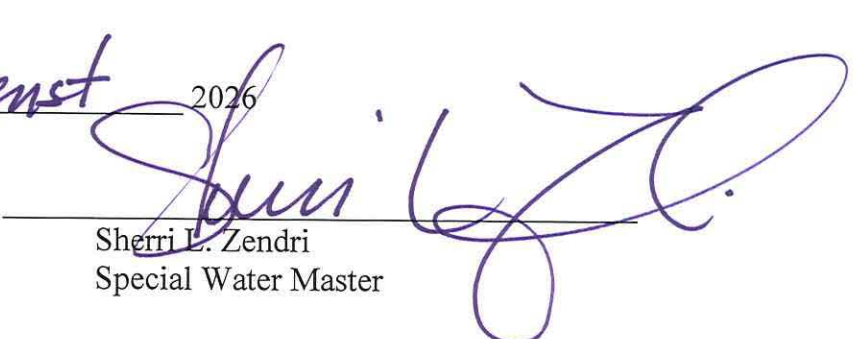
- 4 1. Any parties who have filed a Statement of Claimant that is at issue in this

- 9 4. Parties who have filed a joinder to an objection in this contested case.
- 10 5. Parties who have filed a motion to intervene in this contested case.
- 11 6. Additionally, all parties who are represented by counsel should be
12 removed from the Court Approved Mailing List as long as their
13 representation remains active.

14 Attachment A to this order includes a list of all parties being removed as
15 well as those who will remain on the CAML for this case.

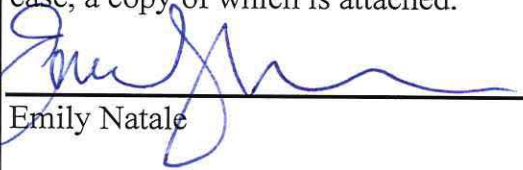
16 As this case has a long and complicated history, it is possible a party may be
