24 the correct dates for the deadlines associated with the Initiation Order are as follows:

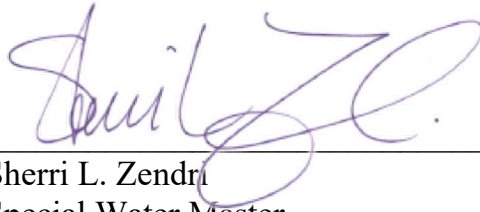
- 25 **1. Declaration.** USFS shall review all SOC’s relevant to this contested case and

1 pursue in this contested case.

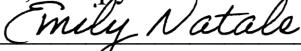
2 **2. Draft Abstracts.** USFS shall file draft abstracts for claims eligible for
