17 **DESCRIPTIVE SUMMARY:** Claimant Augustine Avechuco is ordered to provide
18 documentation of an appropriate basis of right no later than **October 30, 2026.**

20 This contested case involves a well located within the subflow zone of the San
21 Pedro River. On April 19, 2026, claimant Augustine Avechuco requested a status
22 conference which occurred on May 28, 2026. During that conference, Mr. Avechuco was
23 ordered to meet with the Arizona Department of Water Resources (“ADWR”) to discuss
24 options for an appropriate basis of right for his well. On July 1, 2026, ADWR filed a
25 summary of a June 23, 2026, meeting between Mr. Avechuco and ADWR.

27 **IT IS ORDERED**, no later than **October 30, 2026**, Mr. Avechuco shall file with
28 the Court documentation showing that an appropriate basis of right has been filed with

1 ADWR or his claim will be dismissed.
