17 abstracts no later than **October 19, 2026**.

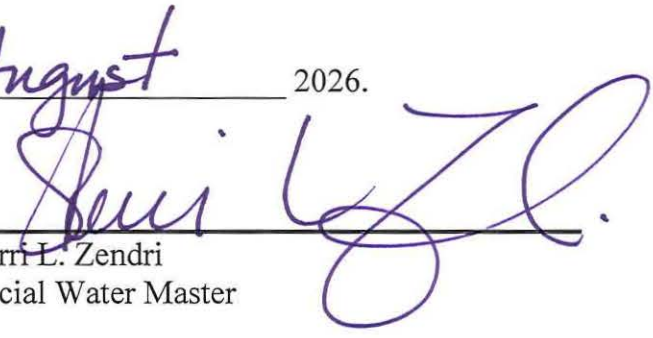

23 abstracts for statements of claimant 39-5622 and 39-5623.

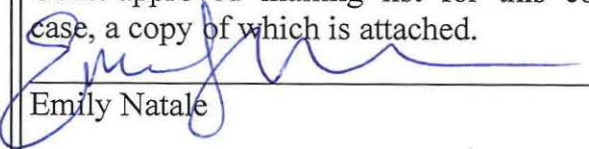
24 **IT IS FURTHER ORDERED** parties may file comments on the draft abstract no
