18	On September 29, 2023, the City of Tombstone ("City") filed an Expedited Motion to		
19	Continue Scheduling Conference and Motion to Extend Stay. This case was initiated in		
20	February 2019 and there have been at least five (5) requests from the City to extend time or		
21	reschedule conferences. The City has claims for 25 surface water springs and three (3) wells.		
22	The adjudication of the wells has already been stayed until the Arizona Department of Water		
23	1		

1	Resources (ADWR) completes a report on the subflow depletion test. A decision from the	
2	Court on this report will be no earlier than March 2024. The claims for the springs have been	
3	stayed since October 2020 pending collection of three years of spring flow data. The City	
4	now requests that ALL claims, surface springs and wells, be adjudicated together and requests	
5	a stay of all claims until after the completion of the subflow depletion test.	
6	During the past three years, the Court received an annual status report regarding the	
7	progress of this case. The October 23, 2023, status conference was the opportunity for the	
8	City and any Objectors to provide the Court an update for the last twelve months. In lieu of	
9	a status conference, the Court requires a written update	
10	IT IS ORDERED that the parties will file a joint status report by October 23, 2023.	
11	The report shall include, at a minimum, updates on the following:	
12	1. Progress on collection of spring flow data, especially Clark and Rock Springs.	
13	2. If Clark and Rock Springs still have not had any data collection, an action plan,	
14	including dates, of how data will be collected or estimated.	
15	3. Progress, or an action plan, regarding debris removal, repairs, and	
16	improvements to the springs where they are necessary for data collection.	
17	4. The status of any negotiations including whether any party still has unresolved	
18	objections and what are the objections.	
19	5. Why the City has changed course and decided all claims should be resolved	
20	together.	
21	6. Without providing the locations of the City's wells (for security purposes),	
22	provide an estimated distance of the wells from the subflow boundary.

Once the status report is reviewed, the Court will determine if all claims for the City should be stayed and adjudicated together.
