
On December 20, 2022, counsel for Charles T. Cleveland filed a Status Report which stated that draft abstracts had been distributed to the parties. San Carlos Apache Tribe, the City of Phoenix, the United States, and Salt River Project responded with either approval or comments. No responses were reported from the Gila River Indian Community, the Tonto Apache Tribe or the Yavapai-Apache Nation. Counsel for Charles T. Cleveland expressed the

1 hope that final approval of a stipulation among the parties can be reached by March 1, 2023.

5 Apache Tribe and the Yavapai-Apache Nation shall either approve the draft abstracts or

9 **IT IS FURTHER ORDERED** that counsel for Charles T. Cleveland shall file
10 stipulated abstracts with the Court no later than **March 1, 2023**, or if no agreement can be
11 reached on the objections, a status report.
