The Court notes that Ms. Garcia has filed a statement of claimant with the court and properly mailed a copy of all of her documents filed with the court to all parties. The Court inquires if Ms. Garcia is pursuing her claim to a water right and whether she has spoken with Ms. Williams about Mrs. Williams assigning her statement of claimant to Ms. Garcia.

Ms. Garcia affirms she is pursuing the claim to water right and has not spoken with Mrs. Williams. She did receive an assignment by mail and is waiting on signatures.

The Court inquires if Ms. Garcia filed her statement of claimant with ADWR.

Ms. Garcia affirms, she mailed the statement of claimant to Ms. Parks and no one else at ADWR.

Ms. Parks did not yet receive it.

The Court will check the ADWR public records after this hearing for Ms. Garcia's statement.

The Court inquires if the water source is a well and if there is any other source of water.

Ms. Garcia affirms it is a well and there are no other sources.

The Court explains how wells with a priority date after 1919 in the subflow zone are permitted and receive water rights. The Court issued a report concluding that owners of wells must apply for and receive permits from ADWR to use appropriable water before the court can adjudicate a water right. The report is currently under review. Therefore,

IT IS ORDERED staying this case pending a decision on the report.

IT IS FURTHER ORDERED adding Mark McGinnis on behalf of Salt River Project ("SRP") to the Court-approved mailing list.

If the Court is unable to locate Ms. Garcia's statement of claimant in the ADWR public records, Ms. Garcia will contact ADWR to correct the issue.
