ORDER TO SHOW CAUSE

CONTESTED CASE NAME: *In re Edgar and Lorraine Dinwiddie*
HSR INVOLVED: San Pedro River Watershed Hydrographic Survey Report.
DESCRIPTIVE SUMMARY: Telephonic hearing set for October 7, 2021 at **2:15 p.m.** to show cause that Statements of Claimant shall not be dismissed.

Edgar and Lorraine Dinwiddie (“Claimants”) filed Statements of Claimant with the Arizona Department of Water Resources. They claimed a right to water for domestic, stock watering and irrigation uses. The Arizona Department of Water Resources investigated the

1 claim and found potential water rights for water for stockponds, domestic, and irrigation uses on
2 the land.

3 Pursuant to A.R.S. §45-256, the Special Master shall provide claimants who filed timely
4 objections with a fair and reasonable opportunity to present evidence in support of or in
5 opposition to the report filed by Arizona Department of Water Resources. Mrs. Lorraine
6 Dinwiddie filed an objection to the report. Additional objections were filed by other claimants.
7 A Status Conference was set for August 18, 2021 to determine if the Claimants and the current
8 landowners intended to pursue claims for water rights. Notice was sent to the address for Mr.
9 and Mrs. Dinwiddie reported on the Objection and to the address publicly available from the
10 Cochise County Assessor for Keith Dinwiddie and Guadalupe Ramirez Durazo, the persons
11 identified by the Cochise County Assessor as the owners of tax parcel 104-41-001. Neither the
12 Claimants nor the reported land owners appeared at the Status Conference. Due to lack of
13 participation in this case,



18 Claimant 39-5363, 39-5364, 39-5365, 39-5366, and 39-5367 should not be dismissed and no
19 further proceedings undertaken in this case. The hearing will be conducted using the Court
