3 for the purpose of allowing Lupita Ramirez Durazo Dinwiddie to appear and state whether she
4 intends to pursue claims for water rights investigated by Watershed File Report 111-24-CDC-006.
5 If Ms. Dinwiddie appears at the status conference and states that she intends to pursue water right,
6 then there will be a discussion about the future proceedings in this case.
