
1. A statement about the status of the documents requested from the National Archives. If the documents have been received, the report shall state the date the documents were distributed to the objectors.
2. A statement about whether the objectors have provided comments or approved the map prepared by Mr. Bundy.
3. A statement about whether the Objectors have requested Mr. Bundy to provide additional information. If additional information has been requested, Mr. Bundy shall describe the efforts to obtain the information and the date distributed.

The report shall be filed with the Clerk of the Court and copies provided to each person listed included on the court approved mailing list, a copy of which is attached.
