2:40 p.m. This is the time set for an Order to Show Cause Hearing before Special Water Master Susan Ward Harris.

The Court reset this matter due to Mr. Bundy’s nonappearance at the December 15, 2021’s hearing. Mr. Bundy has not appeared in this proceeding, the Court will stand in recess for ten minutes to allow him additional time to call in.

2:42 p.m. The Court stands in recess.

2:46 p.m. The Court reconvenes with all above-named parties present and landowner, TC Bundy, on his own behalf as trustee of the W.J. Bundy Trust.

Mr. Bundy informs the Court that there are two other trustees, his sister Sharon Bundy and his niece, Tasha Bundy. The Court asks if their addresses should be added to the Court-approved mailing list, Mr. Bundy does not believe it is necessary.

Mr. Bundy states that he intends to pursue a water right. ADWR did find that there is irrigation and domestic use on the property. Mr. Bundy is unsure what claim he’d like to pursue, the Court will include the information for the University of Arizona’s water program and National Archives. The parties provide their numbers on the record for Mr. Bundy so he may contact them and attempt to come to an agreement to resolve the objections filed to the report prepared by ADWR in response to the Statements of Claimant filed by Mrs. Bundy.

The Court will set a Status Conference in about six months to allow Mr. Bundy time to request records and confer with the other parties.

3:01 p.m. Matter concludes.

LATER:

A status conference shall be held on **July 12, 2022**, at 1:30 p.m. to determine whether the parties have been able to reach an agreement to resolve the objections to the claimed water rights.
