Mr. Brown states that the status from the National Archives on three Homestead Patent Entry Applications is “awaiting shipment.” Mr. Brown states that he needs these documents before he can move forward. Mr. Brown states that he is having a difficult time in mapping the acreage that is supposed to be associated with the water right.

Sara Ransom states that she is awaiting documents from the National Archives before moving forward.

Christina Jovovich states that ASARCO is an objector in this matter.

Mr. Brown states that he has done a lot of work and needs to review the documents from the National Archives before moving forward.

Carla Consoli states that she and Mr. Brown met and conferred in advance of today’s status conference due to the complex nature of the case. They have spoken about the Nature Conservancy’s property, the sever and transfer, the Conservation easement, etc., which are intertwined with the properties owned by Mr. Brown’s clients, and how the claims for water rights will be divided. Ms. Consoli states that she and Mr. Brown will need some time to confer with their clients once the documents have arrived. They want to assemble a single set of abstracts with the maps to present to the objectors so that all parties are viewing the same set of papers.
