Mr. Murphy agrees with Mr. Hood and believes this matter will be settled shortly.

Ms. Montgomery does not anticipate that there will be an objection but would like sufficient time to review the abstracts to stipulate to with her clients.

Mr. Sparks agrees with Mr. Hood and does believe it worthwhile to pursue a settlement. He reports that he has been updating the United States on the issues, what the meetings with ASARCO entail as well as the outcomes.

Mr. Staloff agrees with Mr. Sparks and will continue to work with the parties.

Mr. Gelhert states that he has prepared a draft abstract and will provide it to ASARCO and San Carlos Apache Tribe prior to their meeting.
