19 County Superior Court on September 26, 2005, and pursuant to that order, on October 7, 2005, the
20 Arizona Department of Water Resources (“Department”) issued a news release to media within the
21 area of the Little Colorado River Adjudication informing the public of the dismissal of this case. The
22 Special Master posted the news release on his website.

23 On September 30, 2005, the Special Master mailed a letter to each of the seven claimants who
24 had filed objections to the Department’s Supplemental Contested Case Hydrographic Survey Report

1 (“Supplemental HSR”) informing them of the Court’s dismissal of this case. The Special Master

3 Court nor the Special Master will take any further action concerning the objections filed to the
4 Supplemental HSR or any other matter in this contested case.

5 Neither the Department nor the Special Master has received any inquiries or requests regarding
6 this contested case which would require the Court’s consideration. The Special Master thanks the
7 claimants and counsel who participated in this matter for their cooperation in concluding this case.
