Pursuant to order of the Arizona Supreme Court dated June 21, 1993, designating the attached list of attorneys as judges pro tem or commissioners pro tem to assist this Court in reducing trial delay pursuant to the written order of the Presiding Judge of the Superior Court, it is,

ORDERED designating those attorneys on the attached list as judges pro tem or commissioners pro tem of this Court for the period of July 1, 1993, through December 31, 1993, to hear and decide matters that may be duly assigned to them as a judge pro tem or a commissioner pro tem by the Presiding Judge, the departmental presiding judges or the Court Administrator's Office without further written order.

ORDERED appointing said Judges Pro Tempore for the purpose of performing wedding ceremonies, subject to the following limitations and conditions:

1. No fee or other compensation shall be solicited or accepted for the performance of any wedding

ceremony; and

2. An order similar to the one attached must be submitted for the Presiding Judge's signature prior to the performance of the wedding ceremony, and filed with the Clerk of the Court along with the marriage license.
