In accordance with the requirements of Rule 77j, Rules of Civil Procedure, Rules 28.1 and 28.2, Rules of Criminal Procedure, Rule 11, Rules of Civil Appellate Procedure, and Rule 2.8, Local Rules of Practice for Maricopa County, the Clerk of the Court must accept and maintain custody of items of evidence.

In Superior Court Cause number CR95-91920, CR93-92574, CR93-92576, CR94-91187, CR94-92394 items of evidence are currently housed at the Central Court facility.

Accordingly, upon request of the Clerk of the Court, Judith E. Allen, and good cause appearing therefor;

IT IS ORDERED AUTHORIZING the Clerk of the Court through Michael Jeanes, Associate Clerk of Court Services, to transport those items of evidence as specified below from the Central Court facility (201 W. Jefferson, Phoenix) to the Southeast facility (222 E. Javelina Avenue, Mesa).

CR95-91920 exhibit is a brown paper bag containing nickel plated Charter Arms Bulldog gun, serial # 1115890, barrel and chamber swabs. Brown paper bag containing white metal knife with laminated handle (wood) and dark colored leather case. Brown paper bag containing non-folding knife 9" blade, 14 1/2" overall, possible blood drop on right side of blade.

CR93-92574 exhibit is 2 speed loaders with bullets, 12 like bullets total, Smith & Wesson handgun serial # B5893, 44 caliber, 10" divers type knife with pouch, manila envelope containing 12 live bullets.

CR93-92576 exhibit is a handgun serial # 207805, sealed bag containing two magazine clip holders and 24 live bullets, sealed bag with clear plastic bag inside containing 64 rocks and 1 chunk of yellow-colored rock-like substance purported to be cocaine, sealed bag containing razor blades, glass pipe with residue, small blue holder, small black holder and small piece of burnt residue, opened brown bag containing steel

wool, small metal wires, clear glass container, small piece of clear plastic baggie tied in knot , glass pipe with residue and small piece of burnt residue, clear sealed bag containing one small black leather notebook, foodstamps booklet (amt. undetermined), clear sealed bag containing opened small blue gun box, small red & white box marked PMC cartridges, 11 cartridges, Gold Parts Ordering instruction sheet and White Parts Ordering Instruction Sheet.

CR94-91187 exhibit is a sealed envelope purported to contain two flasks with Liquor in them 4 glasses of which two glasses broken.

CR94-92394 exhibit is a brown envelope containing handgun serial # 1289081 and black holster.

Reason for transport is for purposes of returning the items of evidence as specified back to the Southeast facility.
